

## Unknown Cemeteries

### History:

The information on the individuals listed on this page were taken from obituaries given in the Boonville Daily News. Other information is from the Cooper County Records of Deaths for individuals that were not placed in a known cemetery. Heck all of the people who were known to have been buried in Cooper County but for whom we have no cemetery in placed in this category. Entries in orange are from the State of Missouri Record of Deaths

**Old Hopkins Farm Burial Plot** was located in T-46-N, R-18-W either section 28 and 29. Descendants of the Hopkins family report there were graves on some of the land.

**Jeffress Family Home Place Burial Plot** was located in T-47-N, R-17-W, and section 8 in northeast quarter about ½ mile from Speed. The family feels that that Jeffress family had a family burial plot on their land.

**Langkop Lone Grave Plot** was located in T-47-N, R-16-W, and section 10. The location of this grave is rather vague, taken from several references in Johnson's History of Cooper County, Missouri. Other than a surname, nothing is give. The death was a suicide.

**Old Lewis Family Cemetery** was located in T-48-N, R-16-W, and section 35. This cemetery located on the Dillon farm was bulldozed to the ground in about 1965. It was located across the road from the residence. There were in the neighborhood of 15 – 20 graves at this site. Only one notion is given.

**Moon Family Burial Plot** was located in T-47-N, R-19W, section 4, eastern half of the southwest quarter of the northwest quarter. It was reported that there were two graves at this location.

**McArthur Farm Plot** was located in T-48-N, R-17-W, and section 22 near the old residence on the George McArthur land (1991). There was a large old brick residence which stood back from the road and it has been reported that there were a few grave markers near the residence.

**McBride Family Plot** was located in T-47-N, R-17-W, and section 6 on the present day Virgil Chamberlain land (1991). It was recalled that there were pieces of some grave markers on the hillside near his home.

**McCutcheon Farm Plot** was located in T-48-N, R-18W, and section 31 about 1 mile northwest of Pilot Grove on land entered in the names of Brownfield and Roth (1991). This site has not been visited but it is said that there had been old gravestones near where the old residence was located.

**Paxton Family Burial Plot** was located in T-46-N, R-18-W, and section 19 in eastern half of southeast quarter about 2 ¼ miles due south of New Lebanon, Missouri; Mrs. Helen née Rogers Troka and her brother, Herbert Rogers, who lived in this area have verified that there was at one time a family burial plot at this location. It is also report by them and by members of the family that there may have been two burial plots here.

**Blank Farm Plot** was likely located in T-47-N, R-17-W, section 33 or section 28. Mr. and Mrs. Fancier, past residents of Bunceton, are the informants of this burial plot. They clear the plot and kept it mowed. They thought there could be 40 – 50 graves at this site. And the site might have been the location of an old Presbyterian church.

**Smith Family Burial Plot** was likely located in T-47-N, R-15-W, and section 20 or 29. Mr.

Don Carlos is the source of information on this burial site. He said that it had been destroyed by vandals.

**Spring Valley Burial Plot** was located in T-46-N, R-18-W, section 15, in the southeast quarter about two to three miles south and east from New Lebanon. There was a small settlement or village of Black people here after the Civil War. Mrs. Ada Sims has recalled some of these families who lived there: the Morneys, Jackson, Campbells, and Bushes. Mrs. Sims recalled that there was a Baptist church, a school and burial plot at this location.
