### Marriages

### 1865-1978

The translation of these marriage records were made from photocopies of a microfilm of the original church book. As such it often suffers from clarity, rendering translation very difficult indeed. While I am familiar with many of the German surnames I have attempted to retain the original spelling as much as possible. However, I have chosen not to use the German characters such as an umlaut; instead I have reverted to character spelling. My knowledge of German towns and villages is regional and narrow; so use caution when accepting this information.
