Know all men by these present that whereas my husband Wm. JENNINGS in his time made certain Deed of Conveyances of certain lands in Cooper County in the State of Missouri, to his children respectively, and their heirs, that is to say MARTIN JENNINGS and his heirs, CYNTHIA DAVIS (wife of PHILLIP E DAVIS, who is now deceased), to SUSAN WOODS, wife of CHARLES WOODS, and her heirs respectively all of which deeds are recorded in the clerks of the Circuit Court of said county, as the same will move fully and at large appear by reference thereunto. And whereas, I the undersigned POLLY JENNINGS, wife of the said WILLIAM JENNINGS deceased, did not relinquish or otherwise convey my dower interest in and to the said lands or the grantees respectively mentioned in said Deeds. And therefore for the purpose of carrying out the intention of my said husband in the promises, and for the further consideration of ten dollars to mine hand paid by said Grantees (the receipt whereof thereby acknowledged) I have & do by these present, remit release relinquish alien, confirm and convey to the said CYNTHIA DAVIS and her heirs, and unto the said SUSAN WOODS and her heirs & unto ELIZABETH JENNINGS, wife of MARTIN JENNINGS deceased, and the heirs of the said MARTIN JENNINGS, all my right, interest and claim of Dower or other interest in Law and Equity unto them and their heirs forever. That is to say, to CYNTHIA DAVIS & her heirs to the lands conveyed to them by said WILLIAM. To SUSAN WOODS and her heirs and to ELIZABETH JENNINGS, & the heirs of said MARTIN JENNINGS, deceased. It is hereby understood that this instrument or deed is not to impair my right to my proportion of the personal estate of said WILLIAM JENNINGS, deceased. Nor am I in any manner to be held liable or responsible for the goodness of the title to the several or any other tracts of land conveyed aforesaid. In witness whereof I sign, seal & deliver this deed on this Twenty Sixth day of October in the Year of our Lord 1841.
