

A Compilation of Cooper Countians Who Served During the Civil War

This document is primarily comprised of entries from the 1890 census. Like any census record, some census takers had excellent handwriting and spelling, others had terrible handwriting and spelling, some enumerators wrote down every scrap of information and others very little. This census is no different. As a result, the user should be aware of misspellings and other errors; and not regard this document as being totally reliable. Always consult the original and use this document only as a guide. While the 1890 census was designed for Union veterans, on occasions Confederate veterans were included but later marked off the census. I have included Confederate records when available.

There are a number of problems with relying solely on the 1890 census for a listing of Cooper Countians who served in the Civil War. First the census only recorded surviving veterans and widows. Secondly, it did not record Confederate veterans. Thirdly, it was never totally accurate. Fourthly, it did not count those who died during the Civil War or before the 1890 census date. Lastly, it would not count those veterans who came from Cooper County but moved away before the census was taken. Therefore entries from local cemetery records and county histories were included in this listing.

He returned to Virginia, and the war breaking out shortly afterwards, he enlisted in the ranks of his native state in defense of her sovereignty and institutions, and gave four years of his young manhood to the service of the south. He was in nearly all of the principal battles; from Manassas to the final surrender. He held the office of forage master in Buckhaw's battalion.
