

The First Division and The Fourteenth Regiment Illinois Volunteers¹

The following information was taken The First Division Proclamation, the newspaper of the soldiers of the First Division. E. F. Chittenden of Company B of the Fourteenth Regiment Illinois Volunteers edited the newspaper. Surviving copies are: December 4, 1861, published at Tipton, Missouri; December 13, 1861, published at Otterville, Missouri; and January 1, 1862, published at Otterville, Missouri. The name of the paper was changed to the War Eagle And Camp Journal of the Army of the West. The only issue of this newspaper is the January 11, 1862 issue published at Otterville, Missouri.

The First Division was comprised of two brigades. The First Brigade was composed of the Fifteenth Illinois, Colonel Ellis; Twenty-Fourth Indiana, Colonel Wheatley; Twenty-Sixth Indiana, Gaerber; Fryberger's Indiana Battery; Constable's Ohio Battery, and a squadron of the First Missouri Cavalry, under Captain Clinton. The Second Brigade consisted of the Fourteenth Regiment Illinois Volunteers, Lieutenant Colonel William Cam; Forty-Second Illinois Volunteers, Colonel Webb; Sixth Missouri, Colonel Bland; and Captain F. H. Chapman's Battery. The officers of the First Division were: Acting Major General Thomas J. Turner; Acting Assistant Adjutant, C. C. Clark; Acting Assistant Quarter Master, J. Condit Smith; Acting Division Surgeon, O. M. Bryan; Chief of Commissary, Captain W. J. Benner. The officers of the First Brigade were: Acting Brigadier General A. P. Hovey; Acting Assistant Adjutant General, R. F. Barter; Brigade Surgeon, R. B. Jessup; Aides-de-Camp, T. J. De La Hunt, Albert Bliss; Brigade Quartermaster T. H. Walker. The officers of the Second Brigade were: Acting Brigadier General, John M. Palmer; Acting Assistant Adjutant General, William A. Scott; Aide-de-camp, Lieutenant Philip Childs; Acting Brigade Surgeon, George T. Allen; Acting Brigade Quartermaster, John F. Nolte; Acting Brigade Commissary, Lieutenant George A. Poteet.

The Fourteenth Regiment Illinois Volunteers was formed at Jacksonville, Illinois, May 11th, and sworn into the United States service by Captain Pitcher, on the 25th of May. While quartered here, the members of the Regiment received many expressions of kindness and attention from the good people of Jacksonville, which made the transition from home comforts to camp fare far from disagreeable. Our grateful soldiers will long cherish them.

On the 13th of June, while a national flag (presented by the ladies of Jacksonville) was being raised, a sad accident occurred. By the premature discharge of a cannon, which was being used in honor of the occasion, John G. Stilgebouer, of Company B, had both hands blown off – the right arm being amputated near the elbow, the left at the wrist. He was very kindly taken care of by Superintendent Gillett and the inmates of the Deaf and Dumb Asylum until his removal.

June 19th, the Regiment was ordered to Camp Wood, Quincy. July 5th when it went to Canton and Monticello, Missouri, twenty miles above Quincy, on the river, to look for some secession mischief there, where several days were spent scouting, which

resulted in the capture of Honorable James S. Green, United States Senator, a quantity of arms and ammunition, and in emptying one or two secession saddles.

From thence the Regiment was ordered upon the line of the Hannibal and St. Joseph Railroad, here the Railroad property and that of Union citizens was being destroyed. At Monroe Station, the stationhouse, and twenty-three cars were burned, and the telegraph wire destroyed for a long distance. A few days previous to our arrival, a detachment of the 16th Illinois, Colonel Smith, had a skirmish with the enemy at this place, the former occupying the Seminary building and ground, and the later the brush (as usual) half a mile north. Three of their six-pound shots struck the building, but hit no one; the firing from the Union party disabled the enemy's gun, and it is said, made the fur fly from the rebel squad.

Company B was stationed at Shelbina, Missouri, Company D, at Hannibal, Missouri, and Company I at Salt River Bridge, Companies H and K at Chariton River Bridge: the rest of the Regiment at Macon City, the junction of the North Missouri and Hannibal and St. Joseph Railroads.

The Regiment was afterward ordered to Renick and Sturgeon, on the North Missouri Railroad – Company B, F, H and K at Renick, the balance at Sturgeon. While here, we suppose, the Regiment was in more imminent danger of attack and capture than any other place before or since, as the brush was full of guerillas: perhaps we may except the critical position of Company B, while alone at Shelbina and Company I at Salt River Bridge. An inoffensive Union man, at Renick, was captured and driven away by a small party of secessionist for being a Union man.

A detachment from each Company, under Captain William Cam and Lieutenants Shibley and Webster, started in pursuit, capturing two of the rebels engaged in the outrage. About four miles from town, in endeavoring to escape, the Union man was shot by a one-armed rebel Lieutenant, the notorious Bob Sweeney, the ball and shot entering the groin. Supposing they had killed him, or fearing pursuit, his captors fled. The poor man was found, and every assistance rendered by Dr. Stephenson, but he died that evening. This is but one of many like instances which have occurred. Surely, the tender mercies of secession are cruel!

Upon the arrival of the troops at Renick, the remains of a Union flag (now in our possession) were flying, which had been riddled with ball and buck shot by the rebels. A beautiful new Union flag, gotten up by Stephen N. Richmond, now of Company B, and the Union ladies – was raised by the battalion; after they left, it was torn down and carried away.

August 10th, the Regiment was ordered to Jefferson Barracks; remained there till the 13th, and then went to Rolla – the present terminus of the Southwest Branch of the Pacific Railroad – where it remained about seven weeks. While at Rolla, information was received that a large body of rebels were encamped in the vicinity of Spring Creek, twenty-five miles Southwest. Sunday, September 1st, three companies, B, H, and K, one piece of artillery, and Captain Montgomery's cavalry Company, left camp to give them a call. That night they camped fifteen miles distant, at Wright's: breakfasted five miles beyond. While there Captain Montgomery's men shot one or two rebels and took some prisoners. Arriving near Spring Creek, they came upon three or four horsemen – supposed to be pickets – one received four or five bullets; and probably died that day, another – an old man, Jackson, since tried at St. Louis – was captured and the other

escaped. The wounded man was taken to a neighboring house and surgical assistance given by Dr. Stephenson, of our Regiment.

From the best information Captain Montgomery could obtain, he supposed the rebels were at least 1,000 strong, and less than half mile distant. As we had less than three hundred men, it was deemed best to place the six-pounder on an elevation and send their compliments into (what was supposed to be) the rebel camp in a point of woods. Six or seven shots were fired; it is said one man was wounded and carried off. Colonel Price – who was arrested recently by Fremont’s Body Guard at Springfield – was there, and said that when they saw our piece got into position they left, leaving a few men to watch our movements. He said if the troops had followed on, instead of firing, they, the rebels, would have all been captured, as they had no idea of the movement. They had about 150 men; several of them were captured subsequently. The balance of the Regiment, under Lieutenant Colonel Johnson came on that afternoon, and halted four miles back. Colonel Johnson, Lieutenants J. M. Early and McKnight advanced about dusk to where the firing had occurred in the morning. They were fired upon by some thirty rebels, who emerged from the house where the wounded man was left. Colonel Johnson’s horse was wounded; the party left for the Regiment rather briskly; one of them minus a cap, it is said. The next day the Regiment came into camp.

At Spring Creek is a most beautiful stream. It emerges from the base of a high hill or mountain, and in quantity, sufficient to fill an orifice four feet in diameter, and is very clear and cold. It propels a good-sized water wheel for a carding machine at the fountain. It was well worth the journey thither to see it.

From Rolla the Regiment moved to Jefferson City and after a few days stay and the first United States payment, moved toward Tipton. The first night, Oct. __ camped in a stubble field. In the night, a hard cold rainstorm set in, and as no tents were pitched, all officers and men were thoroughly drenched. Colonel Palmer had not a dry thread upon him. The next morning was raw and cold; the wet rails wouldn’t burn, the wet clothes wouldn’t dry, and the soldiers only became warm as they marched. A number took very severe colds. At California 5 miles distant, the Regiment stopped one day, then came on to Tipton. Here it remained in town and in camp 3 miles south till October 21st, and then, as a part of General Hunter’s Division Department of the West, commenced the march for Springfield; reached Warsaw 24th, halted at camp on review 15 miles beyond, 26th noon; remained there one week for provision trains to arrive. November 3rd resumed the march without tents, and arrived at Springfield November 4th; very much fatigued and footsore from the forced march.

On Saturday, November 9th, as General Price had fled and was burning all the forage in his way rendering pursuit suicidal (and perhaps for other reasons best known to the commanding officers) the Division commenced retracing its steps toward Tipton, arriving here on the 19th. On the 26th the Division moved to Syracuse seven miles west, but returned on the 29th, and is now encamped a mile north of the town awaiting orders – and pay.

Company A, Fourteenth Regiment Illinois Volunteers

Company A was formed in Beardstown, Cass County, Illinois in the early part of the campaign, through the efforts of Thomas M. Thompson, under the most favorable circumstances as the people of old Cass were all awake to a sense of their duty; and especially the Ladies of the City, whose names are inscribed upon the memory of every member of Company A. for their kind, useful and much prized donations. They soon succeeded in procuring members sufficient and immediately proceeded to organize. Thomas M. Thompson was elected Captain; John F. Nolte First Lieutenant; Henry Rodecker Second Lieutenant. The company was ordered to Jacksonville and mustered into the three months for State service; remaining there but a short time until it was called upon to enter the U. S. service for three years unless sooner discharged, which call Company A almost unanimously answered and were mustered in the and the oaths administered by Captain Pitcher.

The Regiment was soon ordered to Quincy where they drilled for several weeks under the command of Colonel J. M. Palmer; were ordered from there to Canton, Missouri; since which time we have marched from place to place in search of Secesh, which to our surprise have not as yet been able to fine one in arms against the Government.

Captain Thomas M. Thompson resigned his position as Captain, about the 5th of December at Tipton, Missouri

We have lost five men by death, discharge and desertion as follows: By death - H. D. Waggoner, at Quincy, in August, of consumption; James B. Fletcher, (Commissary Department,) at Quincy, in September; William Watson, in General Hospital at St. Louis, in November. By discharge - Bruno John, in October. By desertion - Charles Hatfield, November 1st at Turkey Creek.

Company B, Fourteenth Regiment Illinois Volunteers

Company B. was organized in Shelby County, Illinois in the month of April. Upon the news of the reduction of Fort Sumter, there was much feeling by men of all parties. Honorable. S. W. Moulton and Thomas W. Harris two very prominent men of the Democratic Party came out very strongly for the Union. Messrs. Henry and Read and other leading men of the Republican party were untiring and more outspoken than ever – all desirous of burying party issues, and prepare the people of Old Shelby to furnish her freemen for the Nation's defense.

But to M. L. Webster, however, belongs the honor of commencing the formation of a Company – his own name standing first on the list of Volunteers. Cyrus Hall, D. C. Smith, and other prominent citizens cooperated with Mr. W., and the list began to fill up rapidly. When Mr. Hall – who served as First Lieutenant through the Mexican War – volunteered, and signified his willingness to be their leader, recruits sufficient for a full company were soon obtained. As many as could conveniently assembled nearly every day for drill, and were instructed in the rudiments of scientific man-killing by Messrs. Hall, Webster and Steinly.

The Company now being full, an election for officers resulted as follows: Captain – Cyrus Hall; First Lieutenant – Dudley C. Smith; Second Lieutenant – M. Leander Webster; Orderly Sergeant – George A. Poteet; Sergeants – Fred P. Harding, James J. Durkee and Jerome J. Hinds; Corporals – M. H. Copeland, Eleazor Slocum, James Dugan, E. F. Chittenden; Ensign – Frederick Steinly.

Orders came for us to go to Jacksonville where we were to be mustered into service, The Ladies – the mothers, wives, and sisters of the Volunteers – left nothing undone which could add to their comfort; and the day the Company started, the ladies, through Honorable S. W. Moulton, presented a beautiful silk Flag (costing \$53) with an excellent and patriotic address. Captain Hall, for the Company received the Flag, with an appropriate response. Honorable Thomas W. Harris, Reverend Mr. Harkey, and others also made remarks. After bidding adieu to their friends – to some it has already proven a last farewell – the Company marched to the cars. This was Tuesday, May 7th. Nothing worthy of special notice occurred on the way to Jacksonville; arrived there on Thursday morning. On Saturday, May 9th, before being sworn into the State service “for thirty days subject to the call of the President,” an opportunity was given for any to decline, when twenty-two stepped out – the balance took the oath gladly. The ranks were soon filled with men who can fight.

The Company was sworn into the United States service May 25th for three years or during the war.

Many changes have occurred in the Company since its organization. Captain Hall was appointed First Major, and Lieutenant Webster chosen Captain of Company H, in the 7th Illinois Cavalry, in September. Subsequently Lieutenant Smith was chosen Captain;

George A. Poteet First Lieutenant, George Wright Second Lieutenant, J. J. Hinds Order Sergeant, Henry Harbaugh, George E. Lowe, Third and Fifth Sergeants, and Hiram Collins Corporal.

One Sergeant and four Corporals were chosen after entering the United States service, viz: Frederick Steinly, and R. H. Ridgeway, Samuel Huson, Henry Harbaugh and Charles S. Woodward. Subsequently Henry M. Peden was appointed Sergeant in Fred P. Hardin's place. William M. Sinclair was also appointed Corporal.

By death, we have lost four men - George L. Kepcha – August 31st; in the General Hospital, St. Louis; John A. Williams, at the same place, September 15th; William Wooff, in camp, September 12th; and Thaddeus K. Martin, At Alton, about the first of November. These were all good men and much respected by both Officers and Company.

By discharge for Disability – Fred P. Harding, Isaac S. Lantz.

By Desertion – Charles V. Miller, William S. Rust. No loss.

The following are absent sick, either in the General Hospital or at home – Joseph Reid, William S. Richardson, Levi F. Hadley, Frederick Holton, Matthew H. Karr, John M. Underwood, Jesse Anderson, Peter DeKolf, Max Woodling and C. S. Woodward.

Daniel R. Steen exchanged for George O. Peck of the 41st Illinois Regiment; R. H. Ridgeway for William White of Company K., 14th Illinois Regiment.

Alexander Livingston and John Spicer transferred to Captain Chapman's Artillery Company.

Lieutenant Poteet has been appointed Division Commissary, but still retains his position in the company.

This, we believe, comprises all the various changes, which have occurred in Company B up to the present time, other than the dreadful misfortune of Mr. Stilgebouer, which was noticed last week. The list of the names of the company as it now is appears on the fourth page. The health of the "Boys" is good at present.

Company C, Fourteenth Regiment Illinois Volunteers

, A. H. Cornman, Esq. Was chosen Captain, William E. Eastham First Lieutenant, D. N. Hamilton Second Lieutenant, and William T. Burnett Orderly Sergeant.

On the 7th of May, orders were received to rendezvous at Camp Duncan, Jacksonville, arrived in camp on the 10th and sworn into the State service on the 11th, taking the following oath: “You and each of you, do solemnly swear that you will support the Constitution and laws of the United States, and the Constitution and laws of the State of Illinois, and that you will obey all orders of the Governor of the State of Illinois, and of all Officers that may be appointed over you; and if called upon by the Governor with thirty days to tender your services to the United States Government, that you will cheerfully tender them under your present organization.” On the 25th of May, in accordance with the above oath, we were called upon to be sworn into the United States service, for three years unless sooner discharged. Orderly Sergeant William T. Burnett, with thirty-two others, refused to tender their services, grounding their arms with the Bayonets to the North! – and taking with them the following certificate of discharge: “___ of Company C, 14th Regiment Illinois Volunteers, is hereby discharged, he refusing to tender his services to the Government under the present call.”

The company was immediately filled up, and was sworn into the United States service by Captain Pitcher, of the U. S. A.

By railroad collision between Rolla, Missouri and Franklin, Missouri, William Stewart, a member of this Company, was killed.

From the time of entering the service the history of the Regiment has been the history of this Company.

The Company was in camp at Taylorville about a week before order to Camp Duncan, Jacksonville. It was sworn into the State service May 11th, and into the United States service May 25th.

Since its organization the Company has lost nine men, died and discharged, viz: - William J. Hirst, was shot by the accidental discharge of a musket on the steamer *Black Hawk*, at Quincy in July. James W. Reed, drowned in the Mississippi by jumping overboard from steamer *Die Vernon*, while laboring under a fit of temporary insanity. The following have been discharged: George W. Tumison, Jerry Engle, Thomas Meteer, John McCauly, Alfred B. Taylor, F. M. Trusler, Thomas Carr, Joseph Freeman, for disability; Fish Cary, for unruly conduct.
