History:

Account of the Cyclone of 1917

"The new Walnut Grove Christian Church had been dedicated July 25, 1915 – the beautiful edifice erected at a cost of \$6000.00 was completely demolished and blown northward across a deep ravine – the wreckage was lodged in a grove of trees or carried out into the adjoining field. The floor was swept clean, except a few chairs and the organ, which was not damaged. Of the scores of monuments in the adjoining cemetery, only three were left standing."

All of these graves are marked with a stone, unless otherwise indicated.

This cemetery was canvassed by the Church of Jesus Christ of Latter Day Saints on 07 Apr 1961. Any changes from that recorded are denoted in blue except for information from the State of Missouri online Death records which are given in orange.
